



Consignment Agreement

Luxe Purses accepts authentic Designer Handbags and Accessories for Consignment on our website LuxePurses.com, and your choice of our other online storefronts on eBay, Le Prix, and Poshmark Marketplaces. These different selling venues give your item multiple exposures to potential customers. By signing this Agreement and consigning your items with us, you agree that Luxe Purses will attempt to sell your item in return for a percentage of the completed sale (plus processing costs). Here are our Consignment Guidelines:

Consignment Merchandise Must:

- Be an authentic Designer Handbag/Accessory
- Be in new, mint or gently used condition
- Have a resale value of \$600+

Luxe Purses will not accept an item into Consignment if it does not match our high quality standards.

In order for us to evaluate your item(s) for Consignment, please submit preliminary photos via email for consideration. You may mail us your items, for consideration, but if they are not accepted you will be responsible for return shipping costs.

Here's How our Consignment Service Works:

1. Submit photos via email to sales@luxepurses.com. Please send low res photos only (72 dpi).
2. When you receive preliminary approval, please ship your item to us, insured and with tracking.
3. Your item will be authenticated and pricing will be set based on the condition and what you would like to sell it for.
4. We will take professional photos of your item and post them on our website with descriptive information and measurements. We will handle all inquiries on your item and will also ship the item once it is sold. Each item will be posted on our website for a minimum of 90 days.
5. At 30 and 60 days you may choose to discount your item to potentially bring about a quicker sale.
6. Once a sale is made and finalized you will be mailed a check for your portion of the sale, minus our 25% Consignment Fee and payment for other processing charges (see second page for details.) Your payout check will be issued 14 business days after payment for your item has cleared our bank. A detailed receipt will be provided to you along with your payout. We also charge \$10-\$25 per item, to cover Authentication fees*. This \$10-\$25 charge is mandatory whether the item sells or not. (*While most items will fall within the \$10-\$25 range, Authentication fees may be higher for certain brands of Luxury Handbags.)
7. If your item does not sell after 90 days, you may choose to extend the Consignment Term, for \$10 per month, per item, or we can return the item to you. Return Shipping costs will be your responsibility as well as payment for the Authentication Fee and a \$75 Service Fee, to cover our production time and listing costs.

If you cancel your Consignment before 90 days, you will incur a Cancellation Fee of \$150.00 in addition to the Authentication Fee, and return shipping charges.

Consignment Fees: Luxe Purses charges a Consignment Fee of 25% on the final sale price of your item plus a per item, Authentication Fee (Authentication fees range from \$10-\$25 and up.) Our 25% Consignment Fee covers Professional Photography, Descriptions and Measurements, postings on our website, and other online selling venues, safe storage of your item, and final shipping to the buyer.

Disclaimers: If our research reveals an item is not authentic, we will return that item to you immediately, at your cost for return shipping, plus you will be charged for the Authentication Fee and an Admin charge of \$50 to cover our time. If an item is sold and later found not to be authentic, you as the Consignor, agree to compensate Luxe Purses for any damages we may encounter.

Please use a trackable shipping service and insure your package, as we are not responsible for items that are lost or damaged, on their way to us. Please call or email to let us know when to expect your package. Once your items have been received and authenticated, they should be posted online within 7-10 business days.
